A Note from Friends' President Micayla Nelson

This fall, two important local issues are on the ballot and the Friends of the Prairie Wetlands Learning Center Board are happy to extend our support to both of them.

First, on all ballots in Minnesota, there will be a question about renewing a constitutional amendment that dedicates proceeds from the Minnesota lottery to conservation-related activities. These funds go to the Environment & Natural Resources Trust Fund, which has "helped local communities protect ecosystems, promote outdoor recreation, improve health outcomes, bolster agricultural resiliency, and support thriving businesses and good-paying jobs" and has provided over \$1.1 billion dollars towards conservation projects in Minnesota since 1988. Over 50% of voters must vote "Yes" in order for the funding to pass, and a blank vote counts as a "No" vote, so please don't skip that question on the ballot.

Second, for voters in the Fergus Falls school district, there are two questions related to a school bond referendum. Question 1 is for a \$48.84 million bond levy to build a new school for 3-5 grades. Question 2 is for a \$910,000 bond levy to build baseball and soccer fields at the new school. The new school would be built on land that the school district has already purchased, across Highway 210 north of the PWLC.

In addition to the great need for an updated school facility in our community, it would be a great benefit for all students who would attend school there to be located so close to the Prairie. The environmental education that students receive at PWLC is unparalleled. Nature-based learning has many benefits to physical and mental health. Having access to a space like PWLC plays a big part in providing those benefits. If we can make it just a bit easier for the students of Fergus Falls to learn their core subjects while also spending time in a beautiful expanse of prairie, the cost of this referendum will be well worth it. There are no downsides to an investment in the education of our future generations, and there is no better time than now to make it happen.

The Friends of the Prairie Wetlands Learning Center Board support voting "Yes" to both ballot questions regarding the Fergus Falls school bond referendum this fall. The Friends' mission is to enhance and promote the understanding and conservation of the prairie pothole region, and having a school nearby, with classes that visit everyday, is an exceptional way to promote a lifelong appreciation for our prairies.

>>> Prairie Science Class Learns about ...

Our 4th graders have been studying the "Big 3" grasses: Indian grass, big blue stem and switchgrass. Students sketch each plant, then record at least 3 observations, usually about the plant's height, stem, seed head and color. Other plants included in our studies are sideoats grama, lead plant, goldenrod, grey-headed coneflower, monarda, and milkweed. We recently began collecting seeds from each of the plants for various uses in our classrooms, as well as for planting in the greenhouse in the spring. In early spring, PSC students will also be involved in snow seeding, which allows them to spread seed directly onto snowy patches. In late spring, they plant their seedlings from the greenhouse in areas of the PWLC that are in need of restoration.

Rud Wasson and I would like to express our sincere gratitude for the impressive response to information we provided earlier this year by local community members. As a result of your letters and phone calls, USFWS regional director Will Meeks committed to fill two of our four vacancies at the PWLC. While we are grateful for this improvement, it is highly unlikely that the USFWS would have the funds to fill the other two positions, so attention is shifting towards seeking adequate budgetary support from Congress to address this gap along with the larger, deeper issue of reversing the 15-year pattern of flatlined annual budgets for the USFWS.

Rud and I believe that of all local organizations, the Friends of the PWLC is the most appropriate one to lead this effort. At the July 8 board meeting, I provided ideas for the Friends to consider after Rud and I met with Mark Musaus, vice president of the Coalition of Refuge Friends and Advocates based in Virginia. Consequently, the Friends of the PWLC voted to form an advocacy group consisting of Micayla Nelson, Jane Stock, Brad Anderson, and myself. Since then, with help from Liz Anderson, we four advocates have organized and mailed a sign-on letter from 20 local partners to our three members of Congress in a unified show of support for a fully funded, fully staffed, and fully operational PWLC and National Wildlife Refuge System. No response has yet been received.

We also drafted a second sign-on letter inviting school boards of past and present school districts who have sent students to the PWLC for field trips. We aim to send this letter to our members of Congress by October 31.

After that, we plan to prepare a 3rd sign-on letter for Friends groups of Minnesota field stations within the US Fish & Wildlife Service to send to our members of Congress.

The main idea here is to continue putting this local and nationwide issue before our members of Congress so it can catch their attention among a myriad of other priorities such as an election, wars, and hurricanes.

Meanwhile, Fergus Falls Wetland Management District manager Neil Powers hosted a tour of the PWLC for Ben Lien, congressional aide in the Moorhead office to U.S. Senator Amy Klobuchar. Mr. Lien also visited separately with Rud and I at Perkins where he encouraged us to continue our efforts to build coalitions of supporters.

Teens and adults who have read or may be interested in reading the book Braiding Sweetgrass by Robin Wall Kimmerer are invited on a walk on Saturday, October 26 from 3:00 pm to 5:00 pm at the Prairie Wetlands Learning Center in Fergus Falls, MN. Please register by emailing friendspwlc@gmail.com.

The purpose of the book and walk is for readers and participants to become more skilled, knowledgeable, and responsible land stewards and ancestors; to weave Indigenous wisdom, western scientific knowledge, and the lessons of plant life; and to imagine a relationship in which people and land are good medicine for each other.




This is the 3rd in a series of walks, you do not have to have attended previous walks to particpate in this Fall walk.




